NEW EVENT: TRIZ FOR BUSINESS AND MANAGEMENT



Finally, it was decided to bring together those who are interested in or already have been applying TRIZ for business and management innovation. Although this branch of TRIZ originated about 20 years ago, its use has been rather limited. One of the major reasons is that engineers and business people speak different languages and see the world differently, and attempts to directly apply classical TRIZ to help with innovative business issues and challenges rarely led to successful results. However, emergence of universal TRIZ tools as well as ongoing adaptation of the existing tools provide positive impact on the situation. The 2-day meeting will be organized within the forthcoming annual conference "TRIZ Developers Summit 2019" which will be held on June 13-15, 2019 in Minsk, Belarus. The section "TRIZ for Business and Management" on June 14-15 will be provided with parallel English/Russian translation service. Everybody who would like to learn about the current state of the art of "Business TRIZ" and network with the users and developers of Business TRIZ is highly welcome to participate. The advantage of gathering in Minsk is that visitors from over 100 countries can visit Minsk visa-free for 30 days provided they travel through Minsk International Airport. TRIZ. Theory of Inventive Problem Solving: Level 1

Vladimir Petrov Springer, 2019, 215 p., ISBN: 978-3030042530

The author of the book, one of the co-developers of TRIZ and a former student of G. Altshuller, presents introduction to TRIZ: its core concepts, ideas, fundamentals as well as TRIZ basic tools which can be directly put to practice by TRIZ beginners. The book is the first publication in the series "TRIZ: from A to Z". Please note that "Level 1" in the title of the book represents the author's own vision and does not fully match certification levels introduced by other TRIZ-related organizations. Nevertheless, it can be highly recommended to anyone who would like to start with TRIZ.

The book first introduces the reader to recent methodological innovations, then provides an overview of established and new TRIZ tools, followed by a collection of case studies and examples of TRIZ implementation in various scientific and social contexts.

Next ETRIA Conference will be held on October 9-11, 2019 in Marrakesh, Morocco.

On November 30, 2018, I participated at the conference "TRIZ for X 2018", which was conducted in Pune, India within Innovation Week organized annually by TRIZ Association of Asia. The conference gathered about 140 TRIZ enthusiasts and users from all parts of the country. This time I spoke about new developments in the area of TRIZ for Business and Management related to studying S-curve of evolution of business systems and the trend of transition to supersystem. The pre- and post- conference days was accompanied by tutorials provided by TRIZ Masters Oleg Feygenson and Alex Lyubomirsky which attracted 50-60 participants each. Next TRIZ for X conference is scheduled for November 15, 2019 in Pune, India.




On December 1, 2018 I presented a keynote at the conference "Agile NRC 2018" in New Delhi, India in front of over 250 Agile specialists. Both Agile and TRIZ target at considerable acceleration of new products development process. Agile focuses on the managing the entire process while TRIZ helps with managing the contextual phases of the development where new ideas and intellectual property are created and problems are solved. Therefore, the both approaches seem to be complementary, and finding intersections can enhance both the process and its quality. While Agile has already a relatively long track in the development of IT, recently it started to be adopted by other product development industries as well.



During TRIZ Expert Days in Sulzbach-Rosenberg, Germany, which went on February 7-8, 2019, I presented my vision of "Extended Function Analysis": a proposal for update of one most widely used tools of TRIZ. The event gathered over 40 German-speaking TRIZ users who already have experience with TRIZ. Main topic of the event was discussion of further improvement of TRIZ-based Function Analysis. For example, the classic version of TRIZ-based Function Analysis is extremely useful to identify and clarify functionality of technical systems, discover innovation potential and perform innovative cost reduction. Yet, developed over 30 years ago, this classic version of the tool has not been well adapted to deal with systems that include "intelligent" and non-material components, such as IT and business systems. Several new additions which were suggested might help to extend TRIZ-based Function Analysis to working with a broader range of systems. Other presentations focused on time modeling and improvement of modeling electronic systems.

- During 2017-2019, a series of public TRIZ training workshops were delivered by me in Stockholm, Sweden where participants of dozens of Swedish organizations were trained and certified. As a result, the main organizer of these workshops – RISE (Research Institutes of Sweden, a government owned organization with 2500 employed R&D professionals from diverse areas of science and technology, <u>www.ri.se</u>) has decided that it is time to establish a professional network of TRIZ users in the country and even beyond – a Scandinavia TRIZ user group. The first open networking meeting is scheduled for September 4, 2019 in Stockholm. For more details please contact us.
- Announce: TRIZ Review, a new journal has been launched by MATRIZ, The International TRIZ Association. I joined the Editorial Board of the journal. The prime issue will be published soon. It will include English translation of the first ever paper on TRIZ by G. Altshuller and R. Shapiro, *The Psychology of Inventive Creativity*, as well as a collection of selected papers from past TRIZfest conferences to expose the diversity of modern TRIZ.
